Chemical nature: Tolfenamic acid is 2-[(3-chloro-2-methylphenyl)amino]benzoic acid) - one of the class of non steroidal anti-inflammatory drugs (NSAIDs).

Trade Name: **Tolfedine 6mg and 60mg Tolfenamic acid/Tablet**

Other Names: This SDS is intended for two different tablet, differing in the quantity of active ingredient in the tablets.

Product Use: Non-steroidal anti-inflammatory for use in dogs as described on the product label.

SECTION 2 - HAZARDS IDENTIFICATION**Statement of Hazardous Nature**

This product is classified as: Not classified as hazardous according to the criteria of SWA.

Not a Dangerous Good according to the Australian Dangerous Goods (ADG) Code.

Risk Phrases: Not Hazardous - No criteria found.

Safety Phrases: S22, S45, S24/25. Do not breathe dust. In case of accident or if you feel unwell, contact a doctor or Poisons Information Centre immediately (show this SDS where possible). Avoid contact with skin and eyes.

Emergency Overview

Physical Description & Colour: White to off-white tablets packed in foil blisters.

Odour: No odour.

Major Health Hazards: no significant risk factors have been found for this product. This is a physiologically active product and so contact should be minimised, especially if the user is taking a form of medication, as interactions can sometimes give unexpected and undesired results.

Potential Health Effects

Exposure to this product from normal use will not usually result in any health related problems. However, we note that exposure to tolfenamic acid as a medication has resulted in reports of headache, allergy (hypersensitivity), shaking, usually of the hands (tremor), fatigue, disturbances of the gut such as diarrhoea, constipation, nausea, vomiting or abdominal pain, ulceration of the stomach or intestine, balance problems involving the inner ear (vertigo), a state of well-being, optimism and cheerfulness (euphoria), green colouration of urine, difficulty or pain on passing urine (dysuria), allergic skin reactions and blood disorders.

Inhalation:

Short Term Exposure: Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

Long Term Exposure: No data for health effects associated with long term inhalation.

There is also a 60mg/tab version. This SDS is intended for both products.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

SECTION 4 - FIRST AID MEASURES

General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

Eye Contact: No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.

Ingestion: If product is swallowed or gets in mouth, do NOT induce vomiting; wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

SECTION 7 - HANDLING AND STORAGE

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

Storage: This product is a Scheduled Poison. Observe all relevant regulations regarding sale, transport and storage of this schedule of poison. Store packages of this product in a cool place. Make sure that containers of this product are kept tightly closed. Make sure that the product does not come into contact with substances listed under "Incompatibilities" in Section 10. SECTION 10 - STABILITY AND REACTIVITY
